QUANTITY DISCOUNTS Orders for any combination of our Premium Line products of five or more Leg or Arm Systems will receive a 5% discount off Manufacturer's Suggested Retail Price List price. Orders for any combination of our Premium Line products of ten or more Leg or Arm Systems will receive a 10% discount off Manufacturer's Suggested Retail Price List Price, or one free product of equal or lesser value. Orders for any combination of our Standard Line products of six will receive \$5 off per legging.

SHIPMENTS

Orders will be shipped via UPS, or appropriate, charges prepaid, unless otherwise specified by customer.

RETURNS

CircAid Medical Products will not accept product for return 60 days after the date of sale. A 15% re-stocking fee on all returns that are in salable condition is charged to the customer. Please request a return authorization number from a CircAid Customer Service Representative prior to returning merchandise. No returns are allowed if the product has been used except for defective product. If the returned merchandise is determined to be defective, CircAid Medical will at its discretion repair or replace the merchandise. Return authorizations may take up to 5 business days to process. Credits to accounts must be used within one year of issue date and will be applied to outstanding balances only.

Custom-made and special order products are not returnable.

The product will perform according to and under the stated application and use procedures (including alterations as directed) for a period of one year from the date the garment is shipped. The warranty is only valid if the instructions for care are followed properly (hand wash and air dry only) and does not cover normal wear and tear, abnormal care and use, or where it can be shown the application instructions have not been followed correctly.
- Whole Leg EZ™ & Silhouette™ Lower Leg, Whole Leg and Arm Undersleeves:** Product is warranted to be free of defects in materials and workmanship. Product will perform according to and under the stated application and use procedures (including alterations as directed) for a period of 6 months from the date the garment is shipped. The warranty is only valid if the instructions for care are followed properly (hand wash and air dry only) and does not cover normal wear and tear, abnormal care and use, or where it can be shown the application instructions have not been followed correctly.
- Graduate™ Whole Leg, BK Graduate, and Measure-Up™ Arm-Sleeve Systems:** Product is warranted to be free of defects in materials and workmanship. Product will perform according to and under the stated application and use procedures (including alterations as directed) for a period of one year from the date the garment is shipped. Products found to be defective after the first six months can be returned for repair only. The warranty is only valid if the instructions for care are followed properly (hand wash and air dry only) and does not cover normal wear and tear, abnormal care and use, or where it can be shown the application instructions have not been followed correctly.
- Juxta-Fit™/Juxta-Lite™ Ankle-Foot Wrap, T-3 M™, T-3 EZ™, C-3 EZ™ Wrap, T-3 Boot™, and C-3™ Wrap Leggings:** Product is warranted to be free of defects in materials and workmanship. Product will perform according to and under the stated application and use procedures for a period of 90 days from when garment is shipped. The XL T-3 EZ Boot/T-3 Boot, XL C-3 EZ Wrap/C-3 Wrap, XL T-3 M, and the mesh in all size leggings are specifically excluded from the 90 day warranty. The warranty is only valid if the instructions for use and care are followed properly and does not cover normal wear and tear, abnormal care and use, or where it can be shown the application instructions have not been followed properly.
- Ancillary Products (CircPlus™ II Ankle-Foot Wrap, Undersocks, Stockinette, Hand-Cover/Wrap, Shelf-Strap, Knee Cover, etc.):** Product will be replaced if there is any manufacturing defect.
